DOCUMENTS FOR SUBMISSION

- Official valid document accrediting the identity of the right holder.
- A list of performances and fixations exploited or used in audio, visual or audiovisual form, whose intellectual property rights are the object of management by the Entity, as well as the documents that accredit ownership over the former and the exploitation or utilization of their performances and fixations, stating, under their responsibility, that they correspond to their person.

When dealing with right holders of "mortis causa" derivative rights, the following documents shall be submitted to accredit the ownership and the "mortis causa" origin of their rights, stating, under their responsibility, that they correspond to their person, such as:

- A copy of the inheritance document, whether in the form of a will, an intestate declaration of heirs or coparency contract.
- Certification of registering the death with the Civil Register.
- Certification from the General Register of Last Wills and Testaments.
- In any case, a non-certified copy of the deeds of acceptance of the inheritance and a document of proof of compliance with the tax obligations arising from Inheritance Tax or, when applicable, of exemption therefrom.

If there are several inheritors, in addition:

- The public deeds of distribution of estate or of the adjudication of inherited property, or the notarial certificate of registration of the partition of succession.

If the title holder of "mortis causa" derivative rights is a legal person:

- The Deeds of Incorporation registered with the Commercial Register.

The Entity may require the submission of any other documents of proof of compliance with the civil, administrative or fiscal requirements regarding the "mortis causa" acquisition it may deem necessary.

Information clause on personal data protection for AIE Members

G79263414 and registered office at C/ Torrelara no. 8 (28016), Madrid, hereby informs you that all personal data as provided for your registration in AIE will be incorporated into a record of activities of treatment for which AIE is responsible. You consent the processing of your personal data by AIE for all or any of the purposes defined in the Statutes of AIE regarding the management of your intellectual property rights and further services related to this management. In particular, your personal data will be processed and used to carry out the following activities, among others, and all of them included in the abovementioned purpose:

- i. Collection and distribution of the intellectual property rights to which you are entitled as a right holder.
- ii. Access and use allowance to AIE Virtual Office to consult all information regarding the collection and distribution of the abovementioned intellectual property rights.
- iii. Response to all requests you may have with regard to AIE's activity.
- iv. Management of testamentary affairs in case of decease.
- v. Management of embargos and attachment proceedings which might be enforced by the competent authorities on the economic remuneration that might correspond to you.

The processing of your personal data is lawful under Article 6.1 a) and b) of the GDPR (for the purpose of maintaining the legal relationship existing between you and AIE). Your personal data will be preserved until the date you cease to be a member of AIE. After this period, AIE will block your data for the single purpose of meeting any duties or responsibilities that may arise. Once these duties expire, your personal data will be erased. AIE will process your personal data confidentially. Moreover, AIE has implemented adequate technical and organizational measures to ensure the safety of your personal data.

AlE shall allow access to your personal data and/or communicate this data to other management entities holding a Reciprocity Agreement with AlE, to AlE suppliers of technological and document management services, and to the Spanish Tax Agency for the taxation of distributed income. Furthermore, AlE foresees to carry out international transfers of personal data to other management entities located outside of the European Union and holding a Reciprocity Agreement with AlE.
